GENERAL PRICE LIST

These prices are effective as of **Feb. 15, 2010** and are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD:

This fee includes the following:

Arrangement conference with family and clergy, direction of visitation and funeral preparation.

Securing, preparing and filing of the necessary permits, notices, authorizations and consents.

Coordinating arrangements with cemetery, crematory and others involved in the final disposition.

Overhead expenses such as insurance, maintenance, and utility expenses, secretarial and administrative cost, taxes, licenses, equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for a direct cremation, immediate burial and forwarding or receiving remains.)

PREPARATION OF THE BODY:

Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

DIRECT CREMATIONS (Price range available from \$ 3590. to \$ 1395.)

This charge includes local removal and transportation of remains to crematory, services of the staff, procuring death certificates, permits and necessary authorizations, and crematory fee (up to 299 lbs). If you want to arrange a direct cremation, you can use an alternative container. Alternative containers can be made of materials like heavy cardboard or composition materials (with or without outside covering). The containers we provide include uncovered fiberboard (with or without lining), cloth covered soft woods, and wood or veneer caskets. However, they must be acceptable by the crematory. (Prices below exclude applicable taxes).
